Rental Property Issues

Housing & Neighborhood Development Department (HAND) 349-3420

The Rental Occupancy Permit Program helps ensure that rental property in Bloomington is safe and habitable for city residents. HAND staff can help you obtain property owner information and can answer many questions about rentals in Bloomington.

HAND staff will provide assistance if your landlord fails to make requested repairs that are code related.

Reduce, Reuse and Recycle

Trash Collection:

Trash collection occurs weekly. Place trash at the curb the night before your scheduled pickup. Each 35 gal. bag or container must have one \$2 yellow trash sticker attached to it and may not weigh more than 40 lbs. Call the **Sanitation Department** at 349-3443 for your scheduled day or go to <http://bloomington.in.gov> and click the "my bloomington" to find your pickup day.

Yard Waste:

Yard Waste collection occurs on your recycling collection day. Each paper bag or container of waste must have one \$1 green yard waste sticker attached to it and must not weigh more than 40 lbs. Yard waste collection is suspended January through the middle of March.

Recycling:

Recycling collection occurs every other week on your regular trash pickup day. Containers must not weigh more than 40 lbs. **Recyclables need to be sorted into 2 categories:**

1. Paper products.
2. Metal can, glass containers and plastic bottles (#1 through #7).

Nonrecyclable items include foam, some Styrofoam, packing peanuts, light bulbs, window glass, clean plastic bags, plastic ware (cups, plates and bowls), plastic wrap, wire hangers, plastic lids, wax or plastic coated boxes. Refer to the Sanitation Department on the City's website.

Stickers:

Trash and yard waste stickers may be purchased at local grocery or hardware stores. For further information on the City's sanitation services, please call the **Sanitation Department** at 349-3443

YARD MAINTENANCE

City of Bloomington HAND Department 349-3420

Yards must be kept cut and free of noxious weeds. Trash must be in containers and properly placed for pick up. Containers must be removed from the street or sidewalk on same day of the trash pick up.

City of Bloomington Animal Shelter

Dogs and cats must be restrained to "owner's" property by leash, runner, fence, or other appropriate means. Dogs must be restrained by a leash/lead when off their property.

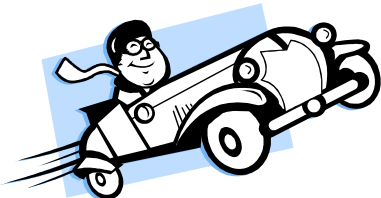

NOISE

City of Bloomington Police Department 339-4477

A simple standard for whether or not noise is excessive if it can be heard in the public right of way or in another person's home. Penalties for violations of the City's noise control ordinance can be a \$50 fine and a charge of disorderly conduct.
